Aga Khan Foundation for International Students

Students from Bangladesh, India, Pakistan, Afghanistan, Tajikistan, Syria, Egypt, Kenya, Tanzania, Uganda, Mozambique, Madagascar, France, Portugal, UK, USA and Canada may be eligible for funding from the Aga Khan Foundation. A limited number of scholarships are provided each year to outstanding students from developing countries with no other means of

financing their studies. Scholarships are awarded on a 50% grant, 50% loan basis through a competitive application process once a year in June or July. The Foundation gives priority to requests for Master's level courses but is also willing to consider applications for PhD programs, when doctoral degrees are necessary for the career objectives of the student.

Civil Society Scholar Awards for International Academic Mobility

The Civil Society Scholar Awards (CSSA) support international academic mobility to enable doctoral students and university faculty to access resources that enrich socially engaged research and critical scholarship in their home country or region. The awards support activities such as fieldwork (data collection); research visits to libraries, archives, or universities; course/curriculum development; and international collaborations leading to a peer-reviewed publication.

The Information Controls Fellowship Program (ICFP) supports examination into how governments in countries, regions, or areas of OTF's core focus are restricting the free flow of information, cutting access to the open internet, and implementing censorship mechanisms, thereby threatening the ability of global citizens to exercise basic human rights and democracy; work focused on mitigation of such threats is also supported. Typically, ICFP fellows have experience in fields such as computer science, engineering, information security research, software development, social sciences, law, and data visualization, among others.

In the past we have accepted writers with no formal writing education alongside those with MFA's and impressive résumés. You will be judged on the quality of the writing sample you submit. Each residency consists of approximately a three month stay in the cottage where Jack Kerouac wrote his novel *Dharma Bums*. Utilities and a food stipend of \$1,000 are included. As writer-in-residence, all you are required to do is live in the Kerouac House during your residency, work on your writing project, and participate in two events—a Welcome Potluck dinner for you, and a Final Reading of your work at the Kerouac House at the end of your residency.

At least one \$2,000 scholarship will also be awarded to a full-time graduate student enrolled in a program relating to water resources for the 2017-2018 academic year. The scholarship will be awarded to the student most qualified by academic performance. Measures of academic performance include the cumulative grade point average, relevance of the student's curriculum to water resources, and leadership in extracurricular activities related to water resources.

Russell E. Train Fellowships support individuals pursuing a master's or doctoral degree in conservation. Each year, WWF supports committed conservationists from target countries to receive financial support for their studies and field research. Applicants can apply to attend any university around the world and must return to their home countries to work in conservation for at least two years after completing their degree.
