UA/NASA Space Grant Graduate Outreach Fellowships

We seek new and continuing UA graduate STEM (science, technology, engineering, and mathematics) students with interests in any aspect of NASA's mission (including elements as diverse as Space and Earth Sciences/Engineering, Science Policy, and Science Education) and in promoting the understanding of scientific research to the public. The fellowship, co-sponsored by UA/NASA Space Grant and the applicant's nominating Department/College, includes a stipend of \$16,000 for one or two years, both in- and out-of-state fee/tuition waivers, student health insurance (if needed), and \$750/year for travel to professional meetings. Though award totals vary based on individual circumstances (whether the student requires/utilizes the out-of-state tuition waiver, numbers of enrolled class units, etc.), 2018-19 fellowships range in value from \$29,868-\$46,850.

Aga Khan Foundation for International Students

Students from Bangladesh, India, Pakistan, Afghanistan, Tajikistan, Syria, Egypt, Kenya, Tanzania, Uganda, Mozambique, Madagascar, France, Portugal, UK, USA and Canada may be eligible for funding from the Aga Khan Foundation. A limited number of scholarships are provided each year to outstanding students from developing countries with no other means of financing their studies. Scholarships are awarded on a 50% grant, 50% loan basis through a competitive application process once a year in June or July. The Foundation gives priority to requests for Master's level courses but is also willing to consider applications for PhD programs, when doctoral degrees are necessary for the career objectives of the student.

Aspen Tech/Data Policy Summer Fellowship

The program is part of the Aspen Tech Policy Hub, "a West Coast policy incubator training a new generation of tech policy entrepreneurs". The fellowship program will be held from June to August in the San Francisco Bay Area, and successful applicants will be paid \$7,500/month for their participation. At the Aspen Tech Policy Hub, we take tech experts, teach them the policy process through an in-person fellowship program in the Bay Area, and encourage them to develop outside-the-box solutions to society's problems. Focus areas include (but not limited to): (1) Cybersecurity; (2) The effects of emerging technologies such as artificial intelligence, the Internet of Things, autonomous vehicles, and quantum computing; (3) Protecting democracy, combating disinformation or misinformation, and election security; and (4) Using technology to help at-risk populations or encourage social justice.

As writer-in-residence, all you are required to do is live in the Kerouac House during your residency, work on your writing project, and participate in two events—a Welcome Potluck dinner for you, and a Final Reading of your work at the Kerouac House at the end of your residency.
